

### USES Approves Taos Expansion

The acting supervisor of the Carson National Forest in northern New Mexico has signed the Record of Decision for Taos Ski Valley's Phase I projects in the Ski Area's 2010 Master Development Plan. That includes two new lifts to access high alpine terrain and upgrades to existing lifts.

Other projects in the plan include construction of a permanent tubing facility, establishing a snowshoe trail system, and developing a lift-served mountain bike trail.

### Breckenridge to get 500 Acres

The proposed development of Peak 6, the resort's fifth mountain, has weathered the U.S. Forest Service approval process and recently received a final go-ahead after an appeal period ended in November 2012.

Although more litigation has been threatened, the Forest Service decision appeared solid enough for the resort



to make a definitive commitment to getting Peak 6 operating in the 2013-2014 season.

Expansion down the Ten-Mile Range means five new alpine bowls and more than 500 new acres of both lift-served and hike-to-ski terrain — a 23 percent increase for the resort. The addition will be the first at the Summit County resort since Peak 10 came on line more than a decade ago.

Peak 6 will have 10 new trails, 13 runs that begin above treeline and the resort's first above-timberline intermediate terrain. Access will be on a four-seat chairlift and a detachable six-seat chairlift from Peak 7. A new warming hut will sit atop of the mountain, and plans call for a restroom facility at the mid-load location.

Resort officials had to fight a long bureaucratic and political battle for the expansion. Prime among opponents' arguments was protection for the endangered Canadian lynx and the prospect of cutting down healthy trees

### RED MOUNTAIN expansion

Red Mountain Resort, located on BC's "Powder Highway" near Rossland, BC, has begun a two-year expansion called Grey Mountain. By the time they are finished with this project, they will have added almost 1,000 more acres of lift-serviced terrain to the resort. Grey Mountain itself is larger than many resorts in North America. They are in the process of building 22 new runs that will expand Red by 60 percent.

To make sure the new runs are as amazing as existing terrain, Red has deployed their run development team, a group of local experienced skiers and boarders who are professionals in all aspects of resort planning and development. Reports from the field are that the new runs look stellar.

Cat skiing will be available on Grey Mountain for the 2012-2013 season. Lift service will be available beginning in December 2013.

Red has updated their plans a bit and purchased a larger Piston Bulley Snowcat — complete with a trickedout cabin that seats twelve — to shuttle skiers and riders to the peak of Grey while they finish their extensive terrain expansion. ◆

### NBC, U.S. Ski Team Partner On Live Coverage

The U.S. Ski Team and NBC Sports Network will partner for first-ever U.S. live TV broadcasts of Audi FIS Alpine World Cup ski racing as part of a pre-Sochi broadcast schedule announced by the network and the U.S. Ski and Snowboard Association.

The live coverage will feature Olympic champions Lindsey Vonn and Julia Mancuso from the Nature Valley Aspen Winternational Thanksgiving weekend along with fellow Olympic gold medalists Ted Ligety and Bode Miller at the Audi Birds of Prey World Cup in Beaver Creek, CO, a week later.

It's part of an extensive coverage package between NBC and the U.S. Ski and Snowboard Association including 11 hours on NBC and 22 on NBC Sports Network.

### Environmental Groups To Buy Royal Gorge

According to the Modesto Bee, a coalition of environmental groups will get together to buy the almost 3,000acre Royal Gorge Cross Country Ski Resort in California. Royal Gorge was put on the block after the area defaulted on its \$16.7 million loan in June 2011.

After spending the last year in receivership, Douglas Wilson Cos., the receiver, agreed to sell the property to conservation groups Truckee Donner Land Trust, The Trust for Public Land and the Northern Sierra Partnership for \$11.25 million.

The groups have until December to raise the necessary funds, plus \$2.25 million more for trail improvements and forest maintenance.

### Wildfire Closes Snow King Summer Operations

The Little Horsethief Fire south of Jackson has burned at least 1,500 acres, prompting Snow King resort to close its summer operations, including the bike and hiking trails, lifts, and alpine slide.

The blaze started near the Little Horsethief subdivision, south of the town of Jackson. The fire has burned to the northeast, in largely uninhabited and rough terrain.

The Jackson Hole resort is not impacted by the blaze, and all highways in and out of Jackson remain open.

### A-Basin Unveils Master Plan

Arapahoe Basin, CO, introduced a longterm master development plan, kicking off what will likely be a years-long process.

The plan includes an expansion of 412 acres into The Beavers, a new lift to access the terrain, a year-round zipline, increased capacity for its snowmaking reservoirs and several lift upgrades.

The public meeting is a first step for Arapahoe Basin, which operates within the White River National Forest. ◆



Skí Boot Review

Scarpa upgraded the Maestrale, which was already a good boot, and made it bad ass. The flex is notably stiffer, but the boot didn't gain any significant weight.

The Maestrale RS (female version: the Gea RS) which is billed as The lightest 120 flex ski boot in the world. The RS's are filling the gap between alpine ski touring and freeride. They weigh in at a shade over 3.5 lbs. which is pretty impressive. They also have an amazing amount of flex when skining up hill and the buckles are pretty light yet not too hard to use.

**SKI RESORTS** gear up for year round operations Resorts add Aerial, Bike Adventures to Summer Operations

Amid a slew of special events involving everything from music to mud, resorts across the U.S. have added and expanded facilities for mountain biking and adventuring in the treetops. Ziplines, canopy tours, and adventure parks have become a hot trend. Often, these are being coupled with Segway tours, bag jumps, disc golf, and such old-school summer options as bungee trampolines and climbing walls.

Here's a look at what's happening.

### New Adventure Parks & Tours

- Mount Sunapee, NM, debuted its Adventure Park, which includes a Canopy Zip-Line Tour from the mountain summit and a Treetop Obstacle Course. It also added Segway tours and disc golf.
- Angel Fire, NM, has a new multi-station Summit Adventure Center anchored by a Zipline Adventure Tour, including its signature 1,600 tandem zipline that soars fifty stories above the ground on its peak-to-peak route. Milder courses suit the less adventurous. The Center also includes bungee trampolines, disc golf, horseshoes, and hiking trails.
- Devil's Thumb Ranch, CO, has created an unusual High Lonesome zipline tour; it starts 25 to 30 minutes from the base area, and is reached by a militarystyle 12-passenger 4x4. Zips range in length from 370 to 1,600 feet, and are up to 78 feet above the ground. Guides explain local and resort history during the three-hour adventure.
- Whitefish, MT, is developing a five-acre Aerial Adventure Park, with five course levels, in front of the base lodge. It was designed by Outdoor Ventures Group and is set to open Aug. 1. The resort also extended its separate zipline tours with the addition of a new 1,900-foot line, the longest at the area.

### Expanded Parks and Tours

Other resorts have added to their existing base-area parks and attractions. Among them:

- Crested Butte, CO., has constructed the Trailhead Tree House Playground for kids, adjacent to its recently-developed Adventure Park. The Playground was built in partnership with the Trailhead Children's Museum and other community supporters.
- Whitefish, MT, expanded its zipline offerings with a new 1,900-foot line, its longest.

### Mountain Bike Developments

Mountain bike expansions are spread across the country as well.

• Crested Butte, CO, bolstered it Evolution Bike Park with a new intermediate trail set to open this month, with a more advanced trail planned for later in the summer. Both add to the park's 25 miles of trails.

### Epic Mix Racing

The introduction of Vail Resorts' (VR) EpicMix Racing gives skiers a chance to see how they stack up against Lindsey Vonn, thanks to a new NASTAR-like addition to VR's acclaimed EpicMix social media program. The incorporation of EpicMix Racing has led VR to drop the 44-year-old NASTAR program from its areas.

The top racers from across the six resorts will be invited to a grand finale event in April 2012, hosted by Vonn, on the Birds of Prey World Cup Course at Beaver Creek.

beginner and intermediate trails, both downhill and cross-country, to its Bike Park. To further make mountain biking accessible to a wider audience, it is adding children's rental bikes, bike clinics, skill centers, and multi-day camps.

- Canyons, Utah, expanded its Bike Park by adding two new flow trails, the more-difficult Dark Hollow trail and the White Rabbit, rated easiest, for a total of five flow trails. Existing trails have been reworked as well. To make it all more accessible, the resort has added quickloading Deason Built carriers to two lifts and launched a Bike Academy.
- Whitefish hopes to construct two new freeride trails, each with more than 2,000 vertical drop, and a total of 4.6 miles of new trails, pending Forest Service approval.

### Next on the Horizon...

Who knows what other activities will take hold in the mountains? No one, which is why it's encouraging to see resorts explore new possibilities.

### Your Responsibility Code

Skiing can be enjoyed in many ways. At ski areas you may see people using alpine, snowboard, telemark, snow bikes, cross country and other specialized ski equipment, such as that used by disabled or other skiers.

Regardless of how you decide to enjoy the slopes, always show courtesy to others and be aware that there are elements of risk in skiing that common sense and personal awareness can help reduce.

Observe the code listed below and share with other skiers the responsibility for a great skiing experience.

### The Code

- Always stay in control, and be able to stop or avoid other people or objects.
- People ahead of you have the right of way. It is your responsibility to avoid them.
- You must not stop where you obstruct a trail, or are not visible from above.
- Whenever starting downhill or merging into a trail, look uphill and yield to others.
- Always use devices to help prevent runaway equipment.
- Observe all posted signs and warnings. Keep off closed trails and out of closed areas.
- Prior to using any lift, you must have the knowledge and ability to load, ride and unload safely.

- LOOK before you leap. Make sure the slope is clear before you jump.
- Do not use the slopes if you are under the influence.

### The Consequences

At each and every ski resort, this Skier Responsibility Code is taken very seriously. Any failure to ski responsibly, and to use good judgment and common sense, can result in the revocation of skiing privileges.

There typically isn't much tolerance for those who disobey the rules. Be aware, that in many cases, state law becomes involved in flagrant violation of boundary restrictions and unreported collisions. The National Ski Areas Association, the National Ski Patrol, the Professional Ski Instructors Association and the National Forest Service officially endorse the above Responsibility Code, and remind you that it is a condition of skiing.

# getting & staying FIT WORKOUT to get ready for winter

It's not too late to get fired up and start those ski workouts today.

### Ball Knee Líft

Place your hands shoulder-width apart on an exercise ball. Tighten your abs & straighten your legs behind you so your body is in a straight line from your head to your heels. Bring your left knee as close to your chest as you can, keeping the rest of your body still. Return to the starting position, then bring your right knee toward your chest. Continue alternating legs. Do 10 reps per side.



### Frog Legs

Sit on a bench. Lean back so that your upper body is at a 45-degree angle to the bench. Place your hands to the outside of your buttocks. Tighten your abs, lift your feet and place your soles together, pointing your knees outward. Slowly straighten your legs, keeping your upper body still (let your feet roll so the sides are touching). Return to the starting position. Do 20 reps.



### Cable Run

Attach two resistance bands to a stable point at about chest level. Stand with your back to the attachment points, and hold one cable in each hand. Walk forward until the cables are taut. Run forward for three strides, then backward for three strides. Continue for 30 seconds. Rest for one minute. Do two to four more intervals.



### Inchworm

Start in a push-up position. Keep your abs tight, your palms flat and your neck in a neutral position. Take small steps forward, keeping your legs straight until your feet are as close to your hands as possible without bending your knees. Then walk forward with your hands until you've returned to the starting position. Do 10 reps.



### Single-Leg Stair Hops

*This is an advanced drill.* Attempt it only if you're accustomed to plyometric exercises. Stand on your right foot with a staircase to your right. Hop up sideways to the first stair. Pause for one second, and then hop to the second stair. Ascend five to 10 stairs. Walk down, rest for two minutes and then repeat using your left foot. Do two sets.



### Single-leg Rotation

Stand on one leg, hold a medicine ball with both hands, and extend your arms in front of your chest. Keep your arms and right leg still, and turn your shoulders as far as you can to the right. Then turn them as far as you can to the left for one repetition. Do 10 to 15 reps, then switch legs.

## **SNOWBOWL** turns 75

1938: Ski area's original base area is established in Hart Prairie. A rope tow, powered by a car engine, pulls skiers uphill.

Fall 2012

1952: The base lodge is destroyed by fire.

1954: Road leading to ski area is extended to the site of the Agassiz Lodge. Agassiz Lodge is built in 1956. Two more lifts are added in 1958 and 1962, but little else is developed.

1970: Summit Properties purchases the area with plans for a base village, however, a land-use plan issued in 1971 restricts development to the existing permit area.

1977: Northland Recreation purchases the ski area and files a master plan to develop the area.

1979: The U.S. Forest Service approves a commercial ski area with new lifts, trails and facilities. Dick and Jean Wilson, the Navajo Medicine Men's Association, and the Hopi Tribe subsequently sue Interior Secretary John Block.

1982: The Hart Prairie chair lift is built. In November, Fairfield Communities purchase area and begins a plan in 1983 that includes the construction of Hart Prairie Lodge, the Sunset chair lift and transfer of the rope tow back to Hart Prairie.

1983: The U.S. Supreme Court declines to hear arguments from Wilson, the medicine men, and the Hopi Tribe. That action affirms the lower courts' decisions and clears the way for more development of the commercial ski area.

1984: Congress creates the Kachina Peaks

Wilderness outside the ski area boundaries.

1988: The U.S. Supreme Court hears a case of multiple California tribes objecting to road construction and logging in U.S. Forest Service areas they want left undisturbed. In a 5-3 ruling, the justices say the federal government is not violating the tribes' religious beliefs because it does not coerce the tribal members themselves to do something contrary to their beliefs.

1992: Arizona Snowbowl Limited Partnership buys the ski area, expands Hart Prairie Lodge and adds a guest service office, a rental shop and a children's ski school. Trail improvements are also made.

1993: Congress passes the Religious Freedom Restoration Act. It says: Government shall not substantially burden a person's exercise of religion, unless it furthers a compelling government interest, and the action proposed is the least harmful method of proceeding.

1997: The U.S. Supreme Court strikes down a section of the Religious Freedom Restoration Act as it applies to states' rights after an archbishop in Texas attempts to tell local zoning officials it would be infringing on his religion to forbid him to expand his church building. It remains for federal use.

2000: The San Francisco Peaks is designated a Traditional Cultural Property, which allows it to be eligible for consideration as an official National Historic Register site.

2001: Snowbowl files an application for

development, snowmaking with the U.S. Forest Service.

2002: Flagstaff City Council agrees to sell 1.5 million gallons of reclaimed wastewater per day during the winter months to Arizona Snowbowl, signing a contract with the business.

2004: The Coconino National Forest releases an environmental study of the proposed changes for public comment. It receives almost 10,000 comments.

2005: Coconino National Forest approves snowmaking with reclaimed wastewater at Arizona Snowbowl. Tribes and environmental groups file suit against the U.S. Forest Service.

2006: A U.S. district judge upholds the Forest Service's decision to allow snowmaking. Plaintiffs subsequently appeal the decision to the 9th U.S. Circuit Court of Appeals. Attorneys for the tribes argue the proposed upgrade desecrates sacred land.

2007: In March, a three-judge panel of the 9th U.S. Circuit Court of Appeals rules Arizona Snowbowl operators cannot use reclaimed wastewater to make snow.

2007: In October, the 9th U.S. Circuit Court of Appeals decides to rehear the case en banc, or with 11 judges.

2008: In August, the 9th U.S. Circuit Court of Appeals says Arizona Snowbowl can make snow with reclaimed water, and go ahead with other improvements, despite tribal objections.

2009: In January, tribes ask the U.S. Supreme Court to review the 9th Circuit's approval of Snowbowl's development. Tribes argue the further expansion of the ski area is in substantial conflict with religious beliefs.

2009: In June, U.S. Supreme Court declines to hear the case. This means the 11-judge decision of the 9th U.S. Circuit Court of Appeals stands, allowing snowmaking to commence. ◆

## KIDS' korner

## **GOOD STUFF** for the kids & grandkids *Kids Alpine Ski Equipment: Should you Rent or Buy?*

Every ski season, parents throughout ski country face the same dilemma. Should they buy or rent skis for their kids? This is a decision that should not be taken lightly.

On the one hand, you might be anxious to have your kids get involved with the sport. In the long run, owning a pair of skis will turn out to be less expensive than renting.

However, not all kids take to the sport immediately. If you invest in a pair of skis that sit in the closet, you've wasted your money.

Unfortunately, it gets even more complicated. One of the reasons that many kids end up hating skiing is because the ski and boot rental process is a total disaster. The lines are often eternal, and kids get restless. In many cases, the kids end up in equipment that does not fit correctly. As a result, they spend the entire day in the lounge.



Kid's skis should be chin high.



### Equipment Compromise

Here are some compromises that might offer a viable solution. Your first step is to research the various ski schools that offer specialized lift, lesson and equipment packages for kids.

Ask advice from other parents.

Sometimes, you can get valuable feedback from message forums such as Epicski.com.

If possible, visit the suggested ski areas and check out the rental areas. Is the staff truly interested in giving the kids the best fit?

Watch the kids classes on the hill. Do the kids seem comfortable? Is there more than one kid crying that his or her feet hurt? Take these observations into account before committing your child to a class.

Once your kids have attended about three sessions, you will be able to determine whether they will stay committed to the sport. Then you should consider buying equipment.

In rare cases, your kids might have found the rental equipment quite comfortable. If that's the case, check the rental shop at the end of the season. They will often sell their rental equipment at a significant discount.

### **EQUIPMENT** for kids

Nothing can be more joyful than watching toddlers make their way down the slopes. In fact, having your kids learn to ski at an early age might even help them develop better balance and movement patterns for life. However, they need to like the experience, and nothing is more detrimental to a child's enjoyment of the slopes than ill fitting equipment.

If you consider the fact that most kids have a lower pain threshold than adults, you will realize the importance of making an informed decision about their ski equipment.

While many children's ski instructors have conflicting views about kids' equipment, there are some basic points on which they agree. For example, most pros agree that skis for beginners should be about chin length. As your child's skills improve, he or she can handle a length between the chin and the nose.

Of course, if you are buying kid's ski gear at the end of the season, you will have to keep in mind that your child might have a major growth spurt in the summer. Your best bet would be to wait for the fall. ◆



### Stroke Awareness & Response Leads to Complete Recovery

Glendale Adventist Medical Center (GAMC) is honored to be the only hospital in all of Los Angeles County to achieve a Joint Commission Certification as a Primary Stroke Center and a certification as a Chest Pain Center as well as other advanced certifications.

The high-level certifications mean that GAMC has processes in place to ensure our community gets the care they need close to home. Take for instance the story of John James.

While eating breakfast getting ready for a doctor's appointment, John suddenly felt the right side of his body lose strength and spasm. His wife realized that weakness on one side of the body was a symptom of a stroke and immediately called 9-1-1.

EMS brought him to the closed Certified

Advanced Primary Stroke Center, GAMC. Within minutes of John's arrival, Dr. David Thompson, a GAMC neurologist and integral part of the stoke team, had already met with John and John's wife Karen. The rapid completion of diagnostic testing enabled the GAMC stroke team to immediately administer TPA (Tissue Plasminogen Activator), to dissolve the blood clot that was causing the stroke by preventing blood flow into John's brain.

For stroke patients like John, getting quick treatment at an Advanced Primary Stoke Center close to home means a life saved without any permanent disabilities. Minutes following the administration of TPA, John's right side began to improve dramatically and his speech started to make sense.

His wife, who stayed with him throughout his treatment saw the miraculous change within minutes.

Only three days after what could have been a life-altering condition, he left the hospital completely recovered.

"John's story is extraordinary and the perfect example of how a knowledgeable and dedicated stroke team like the one at Glendale Adventist Medical Center could change the outcome of one man's life," says Dr. Thompson. ◆
